#### Subscriber membership

Your subscription entitles you to access to the members section of the website <u>www.forexearlywarning.com</u> where are trading tools such as the Heatmap<sup>®</sup> and trade plans are featured.

To use the Forex Early Warning membership service you must have Internet access and a browser, and sign up and create an account with PayWhirl via our website. Here you will need to provide one or more Payment Methods.

Our acceptance of your subscription order request will begin once you receive confirmation of your payment alongside your login credentials email. This is sent directly from our American partners MT2 Enterprises LLC, <u>admin@forexearlywarning.com</u>

By entering the customer portal and adding your details such as your mobile number you are giving permission for your mobile number to be added to our Telegram group in order for you to receive mobile forex alerts.

Your Forex Early Warning subscription will continue until terminated. Unless you cancel your subscription before your billing date, you authorise us to charge the subscription fee for the next billing cycle to your Payment Method (see "Cancellation" below).
